

**Canadian Pet Connection Facility Use Waiver - Doggy Daycare  
AGREEMENT TO HOLD HARMLESS, WAIVER, & ASSUMPTION OF RISK**

I \_\_\_\_\_ understand that my attendance at any doggy daycare, training class, or other pet-related event held at Canadian Pet Connection Inc., 278 Cook St, Meaford, ON, is not without risk to myself or anyone representing myself, as some of the dogs to which I may be exposed, and to which my own dogs may also be exposed, could cause injury due to their difficult nature or temperament. I understand that, even when the greatest of care and attention is taken, there is always a possibility of injury to myself, my dogs, or, my representative.

Canadian Pet Connection shall exercise reasonable care for my dog while my dog is in their custody. I recognize the potential risks involved with group play, dog daycare, training, and other events. I understand that the way dogs interact with one another can be unpredictable, and recognize injury can occur to my dog while co-mingling with other dogs in the Canadian Pet Connection's facility. I understand the risks of injury include but are not limited to, scratches, minor cuts, bite marks, open wounds, major injury or even death. I have determined that the benefits of these activities outweigh the risks. Canadian Pet Connection reserves the right to refuse to provide daycare to my dog for any reason or no reason at all as they see fit.

If my dog becomes ill or injured for any reason while in the care of Canadian Pet Connection, I give permission to Canadian Pet Connection staff to take all reasonable actions to obtain medical treatment for my dog, including the use of a veterinarian. I understand that they will bring my dog to my veterinarian if it is reasonably convenient to do so; otherwise, they will bring my dog to a veterinarian that Canadian Pet Connection chooses. I agree to pay for all costs of such treatment immediately if required.

I represent to Canadian Pet Connection that, to the best of my knowledge, my dog has not been exposed to rabies, distemper or any other contagious or communicable disease in the thirty (30) day period prior to being left at a Canadian Pet Connection facility. I agree to notify Canadian Pet Connection immediately if my dog is exposed to any virus, infection or other transferable illness. I further agree that I will not bring my dog to any Canadian Pet Connection facility or event unless and until my dog is free of any symptoms of illness for a reasonable period determined by a licensed veterinarian. I further agree not to bring my dog to Canadian Pet Connection if my dog is exhibiting any signs of illness that may be harmful to other dogs. Such signs of illness include, but

are not limited to vomiting, diarrhea, extreme lethargy, and red eyes. I represent that I am the sole owner of my dog, free and clear of all liens and encumbrances.

I hereby grant Canadian Pet Connection the right to take photographs of my dog and to post or reproduce any and all photographs taken without limitation, on their website, social media accounts, promotional materials and merchandise. I expressly waive the right to receive any royalty or other payments of any kind related to the use of the photographs. I agree not to sue Canadian Pet Connection and release them from any and all claims, demands, rights, causes of action of any kind related to the use of photographs.

I hereby waive and release Canadian Pet Connection Inc, including their staff and volunteers, from any and all liability of any nature for injury or damage to myself, my representative, my pets, and my belongings which may occur while on the premise for any pet-related event, class, service, or activity. If I abandon my dog with Canadian Pet Connection, they may bring it to a dog shelter of their choice.

I agree to hold harmless and indemnify any instructor, employee, assistant, volunteer, participant, agent, and any other person present at any pet-related service or event for any and all claims by myself or anyone representing or accompanying myself, due to injury or damage of any nature.

## **Policies:**

**Fleas:** It is requested that all dogs in the Meaford Doggy Daycare facility are on a flea and heartworm prevention program. Dogs with fleas are not permitted in the facility. If your dog has fleas, they will be separated from the group and will need to be picked up immediately.

**Clothing and Tags:** Clothing such as coats, bandanas, and boots are not permitted in the doggy daycare facility. A collar without tags may be worn, however it must be cloth or nylan, and with an easy-release buckle.

**Cancellations:** 24 hours notice is required for cancellations. A refund will not be issued for cancellations that are less than 24 hours.

**Pick ups:** Only authorized pick-up persons will be allowed to pick up your dog.

**Spay Neuter:** Dogs are required to be spayed/neutered as soon as is age appropriate.
